Call to Order: The meeting was called to order at 7:00 pm.

**Special Guests:** Councilman John Cartier presented NCC Code Enforcement Report and Community Crime Report to the Commission. NCC proposed budget with no property tax increase and no sewer increase.

Board of Adjustments: No activity to report. One vacant position on board.

Planning Commission: No meeting in May. Nothing to report. One vacant position on board.

**Board of Elections:** Patty reported that Curt Nass filed for position, declared Treasurer. Remaining Commission members (Scott and Logan) will appoint 3<sup>rd</sup> Commissioner, and then 4<sup>th</sup> Commissioner will be appointed. June meeting will need to be changed to June 17 at 7 pm.

**Treasurer's Report**: Curt presented the Financial Report for April 2024 (attached) and a monthly progress budget report for Commission review. Andrew made a motion to accept the Treasurer's report as presented, Dave seconded, all were in favor.

**Tax Collector's Report**: Curt Nass provided tax collector's report. No update on delinquent taxes. One property spproaching the \$1,000 threshold for collection.

Dave made a motion to reappoint Barbacane-Thornton as town auditor, Logan seconded, all were in favor.

# Old Business/President's Report/Correspondence:

Town Hall improvements, Staircase has been completed, awaiting lift. Adding breaking bars to front and side entry doors in Town Hall.

Sidewalks, no update on sidewalk repairs on Bellefonte Avenue. Scott will have an update in June.

Three (3) potholes reported in town.

Edison Lights on Brandywine Blvd., lights were repaired at entrance to parking lot by Scott and Dave.

MacDonough Memorial, will be held June 7, 2024. Jaime Parker will perform and do the memorial and the concert. The memorial will start at 6 pm and the concert at 7 pm.

Summer concerts Jaime Parker for June, Diamond Swing for July, James Spadola for August will also have popcorn and water ice.

Resolution 2024-01 presented for consideration to approve real property tax rate of \$.40 per \$100 of valuation and approve an operating budget to \$220,650 in revenues, and \$295,400 in expenses and approving the stipend fee schedule for FY2025. Scott read resolution in entity. Dave made a motion to approve, Brandon seconded, all were in favor.
