#### Town of Bellefonte, Delaware Town Meeting Minutes, June 17, 2024

Attending: Scott MacKenzie, Brandon Dougherty, Logan Ritchie, Andrew Ritchie, and Dave Brenner, Treasurer and Tax Collector Curt Nass

Absent: None

Call to Order: The meeting was called to order at 7:15 pm.

### Minutes to the Previous Meeting:

Dave made the motion to approve the minutes for May; seconded by Logan, all were in favor.

**Special Guests:** Councilman John Cartier presented NCC Code Enforcement Report, eight (8) open cases, four (4) resolved, and Community Crime Report to the Commission. FY 2025 budget passed by NCC, no property tax increase or sewer rate increase, including and \$8 million for pay increases for NCC Police. Study underway to keep funding for volunteer fire companies, potential for fire fees to be implemented in the future.

Ellen Benitez addressed Rosedale and Bellefonte Avenue intersection and intersections on Rodman that have no stop signs. Scott will follow-up with Debra Heffernan about DelDOT's advice re: these intersections.

Board of Adjustments: No activity to report.

**Planning Commission**: Ice Cream Shoppe wants to add a garage on back of property. Land Use Code is now on website with supporting legislation and published in News Journal.

#### Board of Elections: No report.

**Treasurer's Report**: Curt presented the Financial Report for May 2024 (attached) and a monthly progress budget report for Commission review. Andrew made a motion to accept the Treasurer's report as presented, Logan seconded, all were in favor.

**Tax Collector's Report**: Curt Nass provided tax collector's report. No update on delinquent taxes. Tax bills will go out next month.

Scott recommended donating remaining ARPA funds be donated \$832.16 to Food Bank of Delaware, Brandon seconded, all were in favor.

# **Old Business/President's Report/Correspondence:**

- Town Hall improvements, Staircase has been completed, awaiting lift. Inspections by Fire Marshall and NCC. Fire extinguishers need to be mounted as per Fire Marshall. Hand rail required by NCC to close permit. Lift permit will fulfill requirement of a hand rail. HVAC filters have been cleaned.
- Sidewalks, no update on sidewalk repairs on Bellefonte Avenue.
- About fifty (50) people attended the MacDonough Memorial, very successful community event.
- Diamond Swing for July 12 summer concert. Look next year to possible line up with first Friday downtown events.
- ARPA Website migration not yet completed, should be resolved in a couple of days.

#### **Transition of Government:**

Scott stated that it is the opinion of the Town Solicitor that, although not a quorum, Logan Ritchie and he are the duly constituted governing body of the Town of Bellefonte. As such, Scott made a motion to nominate Brandon Dougherty to the fill the vacant Commissioner chair (expiring 6/2026), Logan seconded, all were in favor. Brandon took his seat. Scott then made a motion to nominate Andrew Ritchie to the Commission (expiring 6/2026), Logan seconded, and all were in favor. Scott then made a motion to nominate Dave Brenner to the Commission (expiring 6/2026), Logan seconded, and all were in favor. Scott said that all seated Commissioners have already taken the Delaware Oath of Office, but asked if anyone wanted to sworn again. There were no takers. Scott said that the only officer to complete registration for office, Curt Nass, was uncontested and is now Treasurer and Tax Collector (expiring 6/2026).

Scott nominated Brandon as President, Dave seconded, and all were in favor.

Andrew nominated Scott as Secretary, Dave seconded, and all were in favor.

- Business Façade Grant Program with a budget of \$10,000 businesses may apply for grants to launch on July 1, 2024, to include windows and include business districts in downtown and Philadelphia Pike, five (5) grants, all work to be done by November 30, 2024. Scott will create application and send out communications to businesses.
- Dangerous intersections-recommend 4-way stop signs, Scott will contact DelDot to inquire about remedies.
- Resolution 2024-02-Kathy MacDonough Memorial Resolution for approval. Scott made a motion to read resolution in title only, Logan seconded, all were in favor. Brandon read resolution in title only. Scott made a motion to approve the resolution, Logan seconded, and all were in favor.
- September 28, 2024, Bellefonte Day and Bellefonte Town Picnic, Andrew made a motion to approve up to \$2,000 for Bellefonte Day, Scott seconded, and all were in favor
